2024 review of the framework

Technical review

Established in 2014, the Local Government Performance Reporting Framework (LGPRF) undergoes a comprehensive review every three years. In 2024, with the support of the Minister for Local Government and the Local Government Performance Reporting Steering Committee (LGPRSC), Local Government Victoria undertook a review of the framework. This included examining its structure, indicators and measures, the governance and management checklist, and the target-setting process.

Submissions for changes were received from nine councils, and three state government departments. These submissions were assessed by a peer panel from 18 councils and one peak body, which developed recommendations for amendments to the framework.

The Steering Committee reviewed and endorsed these recommendations, which were subsequently approved by the Minister for Local Government.

The following sections outline the approved changes.

New framework structure

To ensure the framework remains relevant into the future, its structure will shift from a Service/Financial Area-to-Measure model to an Outcome-to-Measure approach, with a stronger focus on common themes of council performance.



Outcome framework

Structure of a domain

The framework is structured into seven domains. Each domain is based around a single outcome, multiple indicators, targets (where required) and several measures. The relationship between each aspect in the domain can be summarised as follows:

Outcomes are the measurable change or benefit.

Indicators show the desired action that signals progress toward achieving an outcome.

Targets show an anticipated result to be achieved within a specified timeframe.

Measures are the specific, standardised way of quantifying the change for tracking and comparison.

The outcome domains for the LGPRF

The seven domains for the Local Government Performance Reporting Framework (LGPRF) are:

GOVERNANCE Council ensures good governance, transparency and accountability.

COMMUNITY Council is building an active, healthy, and engaged community.

ENVIRONMENT Council supports a safe and climate resilient environment.

RESPONSIVENESS Council provides timely and efficient services.

COST Council provides services in a cost-effective manner.

FINANCIAL FORECASTING Council plans for future financial performance.

FINANCIAL MANAGEMENT Council manages its finances to meet current requirements.

These seven domains will replace the former 15 categories for service areas, financial grouping and sustainable capacity.

For reference purposes, each domain has been given a three-letter prefix. These are:

GOV – Governance **COM** – Community **ENV** – Environment **RSP** - Responsiveness

CST – Cost FIF – Financial Forecasting FIM – Financial management



Aligning the existing measures to the domains

A key focus of the review working group was assessing how the existing indicators and measures align with the new outcome framework. Each of the 59 existing measures have been assigned to its best-fit domain, with the results summarised below.

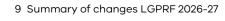
