City of Whittlesea

The Growing Suburbs Fund is a contribution towards meeting critical local infrastructure needs for communities in Melbourne's diverse and fast-growing outer suburbs. It is positioned to quickly respond to the pressures being experienced by interface communities by bringing forward local infrastructure projects that will make a big difference in the day-to-day lives of outer suburban families.



The City of Whittlesea is located about 20 km north of the Melbourne Central Business District. The southern parts of the city are established urban areas and current residential developments are extending towards the north of the municipality.

The City of Whittlesea is home to an ethnically-diverse community, with more than half of the residents from non-English speaking backgrounds. In 2017, the City

of Whittlesea had an annual population growth rate of 4.1 per cent compared with the national average of 1.6 per cent. The current population is expected to grow from around 216,500 in 2017, by 45 per cent to about 383,000 in 2031¹.

Project Description: Funding from the Growing Suburbs Fund will help the City of Whittlesea construct an all-abilities playspace in Mill Park Recreation Reserve which will enable the whole community to play, connect and socialise. It will cater for all ages, with a broad range of play options including physical, social, creative and cognitive.

This Regional All Abilities Playspace will deliver:

- All-abilities play equipment for abilities and ages (from 0 – 18 years)
- Shaded play structures with different levels and challenges
- A large picnic shelter with BBQ
- Artistic features and creative areas for play and discovery

- · Drinking fountains and other public furniture
- Fencing and Landscaping.
