#### Introduction

The following comments are forwarded on behalf of Hume City Council members of the ASU MEU/Private Sector Branch and the ASU Services & Energy Branch. Our combined union Shop Committee was forwarded copies of the Terms of Reference and were asked to seek the views of the members they represent.

A meeting of the combined union Shop Committee was held on Wednesday 16<sup>th</sup> August, which I attended and the following comments are based on the feedback from our members through this process:

### TERMS OF REFERENCE 1.

### Financial impacts

Our members believe that there will be financial impacts on Hume and a new council if a restructure was to occur. They do not see how it could be cheaper to provide services by splitting the municipality.

There would be potential for further redundancies to occur, this would impact considerably on the council/s and includes meeting the possible council redundancy costs plus superannuation redundancy costs for members of the defined benefit scheme made redundant.

A Sunbury only based council would not be entitled to obtain rate revenue from the Melbourne Airport, this would impact on Sunbury ratepayers. We understand that the Sunbury community currently benefits on a proportional basis on the income derived from the Airport rate revenue. A potential outcome is for rates to increase for both municipalities due to such a change. Such and outcome would not be well received by the community.

Another concern we have is what would occur to existing contractual arrangements whether in-house or external? Most of the contracts have different expiry dates and generally operating across the current council, how would they be split? Would there be costs incurred due to breach of contracts with external providers.

Another potential financial impact is that of tourism, a larger municipality such as Hume has far more potential than a smaller council to market the growth of tourism throughout the municipality. Some of the tourist attractions are based in the Sunbury region, which has a benefit in particular to the small business community.

### Economic impact

Our members believe that a Sunbury council would be too small to viably provide all existing services provided by Hume, this would lead to the council either having contractual arrangements with Hume council or alternatively outsourcing some services. The latter option could also impact on Hume as they would have to address whether the revised service was viable or not.

We understand that the Sunbury Ratepayers Association has been indicating through the media that they believe that Hume could continue to provide some of these services under a contractual arrangement, we find this difficult to understand for the following reasons:

- It would not Sunbury Ratepayers Association that would make such decisions, it would be the elected council making such decisions; and
- our members are find it difficult to understand that the people pushing this issue would want to retain Hume as a service provider when they are critical of the Hume Council

It is our view that a likely outcome would be that a Sunbury based council would not want to provide the outdoor physical services. They would have the added cost of providing a suitable depot facility in Sunbury. Hume council would likely want to retain most, if not all of the existing plant equipment as most of it is utilised across the current municipality.

If jobs were outsourced, this would possibly have an economic impact on the Sunbury small business community. Many of the Hume employees are locals, our industry experience highlights that local contractors who would more than likely be employing locals, are generally not successful in winning larger contracts. This would mean that income earned would not be spent within the local business community.

It should be noted that the only town to survive the mergers that occurred during the Kennett Government forced mergers, was surprisingly the Borough of Queenscliffe. They have since outsourced their outdoor physical services to Greater Geelong City Council.

#### Social impacts

There is a concern about how some of the community services currently provided would being split up. This area of Hume's services is extremely important as it provides excellent service to the elderly, people with disabilities, child and maternal services.

Our members believe that any break-up of this service would be detrimental to the community, with a possible outcome of reducing the level of service available due to some duplication of costs, particularly in the management area.

An impact for our members would be about which employees would transfer to a Sunbury council? While a number of employees reside in Sunbury, their services may well be required with the current council and their preference may well be to stay with the larger council due to future career opportunities.

#### TERMS OF REFERENCE 2.

#### Impact on services

As stated we believe that a Sunbury council would possibly outsource some of its services immediately. This would mean that the community would be confronted with a competitive environment from external providers only.

This could lead to the residents paying more for their services, or the quality and level of services being reduced. Our experience shows that where there is an in-house bid, the external providers are much sharper with their pencil when tendering.

The other concern raised in our response to Term of Reference 1., is what happens to existing contracts whether internal or external? If contracts are split, this would lead to the requirement for negotiations for contract variations and likely increases in costs, due to the level of service being changed. If this was to occur, we believe that it would lead to increased costs to the Hume and Sunbury communities overall.

#### TERMS OF REFERENCE 3.

#### Governance impacts

There would obviously be an impact on the Governance as it would lead to an increase in the number of councillors, senior management positions and the administrative support staff. Sunbury residents would have to meet such costs, their current share of such costs is minimal compared to the costs that would be incurred under a new council.

#### TERMS OF REFERENCE 4.

#### Employment patterns

The unemployment levels in Sunbury (less than 6%) are quite low, however, the levels in Broadmeadows are extremely high (in excess of 15%). The impact of splitting the council has the potential to further increase the unemployment levels if services are changed and possibly outsourced.

#### TERMS OF REFERENCE 5.

#### Community diversity

Our members believe that this issue is being pushed by two Sunbury based community groups and would not have the support of the majority of the local community if all of the facts were put before them.

The former Bulla Shire included far more than just Sunbury, taking in Bulla, Craigieburn, Greenvale, Mickleham and Oaklands Junction. The former Bulla Shire ratepayers of the other suburbs mentioned above do not seem to be seeking the same diversification.

One of the issues that council mergers have incurred, is the potential for fringe suburbs to feel as if they are left our as far as services are concerned. We believe that this cannot be argued in Sunbury's case, due to its population density, all of the Hume council services are readily available.

#### TERMS OF REFERENCE 6

#### Attracting new business

The only comment we offer is the fact that the current Hume council has far more potential to recruit new business to the municipality (including Sunbury), by being in a position to offer establishment subsidies. It is difficult to see a smaller council being able to do this at the same level that Hume could.

Melbourne Airport used to have to negotiate for any infrastructure changes with three former councils, (Broadmeadows, Bulla and Keilor), now it only negotiates with one council, Hume. This is an important issue for larger businesses establishing in any area.

#### TERMS OF REFERENCE 7.

#### Infrastructure issues

Hume council has maintained services to the Sunbury community including the former shire office, council chambers and other services. The main issue for our members would be the fact that there is not a suitable depot facility available at Sunbury to accommodate the plant and equipment required to provide the necessary physical services.

To purchase/lease a reasonable sized property to accommodate plant equipment and the appropriate infrastructure would be extremely costly on such a small municipality covering Sunbury only. Our members believe that the impact of such costs would lead to a Sunbury council not providing such services.

#### TERMS OF REFERENCE 8.

#### Administrative, financial & rating impact

It is the view of our members that splitting the council will lead to increased costs to Hume and Sunbury ratepayers and has longer-term financial implications on the communities.

The alternative is reducing the level and quality of services provided, we do not believe that the community would be prepared to accept further reductions. Due to council mergers and CCT, most services suffered either a reduction in the level and/or quality of service being provided. This was mainly due to the new councils, such as Hume, being required by the State Government to meet specific cost reductions within short prescribed timelines.

The only way that municipalities could meet such a demand was to retrench staff based on the level of costs required to be reduced, rather than the level of service provided. We believe that Hume ratepayers did suffer because of this.

#### TERMS OF REFERENCE 9.

#### Other matters

While accepting that the Bracks Government did offer the opportunity for such a review, we are concerned about the affect it is having on our members. They have been confronted with more reform than any other public sector authority over the last decade, due to a combination of firstly council mergers followed by CCT.

#### Existing contracts

Most of them are currently working under in-house bids, which in their view gives them limited tenure employment, usually 3 year contracts with a 2 year extension option. At the same time many of them are earning incomes below recognised poverty line figures.

#### Industrial issues

You will be aware that the ASU has a number of industrial agreements with Hume City Council. They are respondents to the Local Authorities Interim Award, we have a current framework Enterprise Agreement plus a series of Local Area Work Agreements (LAWA's), each covering a specific service provided in-house by council with varied operative dates.

Most, if not all of these agreements would have to be revisited due to the change in services that would be required. While we would see a new council as a successor body and as a consequence, transmission of business would apply, this would mean that we would insist that employees transferring across to a new council would not be disadvantaged in any way.


A new council could not force employees to transfer across to a new council. If an insufficient number of employees with appropriate skills were not willing to transfer and Hume council did not require their services, under our agreements, redundancy would apply. This would be a further financial burden on both Hume and Sunbury ratepayers.

#### Workplace morale

Our members believe that it is only a small minority of Sunbury ratepayers that are promoting a Sunbury council. The issue is creating even more angst amongst our members by creating further uncertainty over their future. The local publicity that this issue has brought with it, is having a considerable affect on their morale.

#### Conclusion

For all of the above reasons, the greater majority of our Hume City Council members do not support splitting the council by establishing a Sunbury Council. As has been mentioned in our letter, we would be happy to make an oral submission, which would include Hume Shop Committee representatives.

Submission on the Removal of Sunbury out of Hume and establishing a new stand alone municipality consisting of all of that area from Deep Creek to the existing boundary with Melton and Macedon Ranges.

Since the Local Government Review Board put Sunbury into the "City of Hume" and not as a stand alone Shire similar to Melton or established a Shire incorporating Gisborne, Riddells Creek, Romsey, Lancefield, and Macedon, many local residents felt that they have been deceived or cheated.

At the time of the review the majority of Sunbury residents believed that we would not be part of "Hume" and it came as a complete surprise to discover what was to become the greatest disappointment the then Government would perpetrate.

Even now recent surveys – Regional Newspaper Telephone Pole – Sunbury Chamber of Commerce Pole – reveals that over 90% of Sunbury Residents still want to have Sunbury removed from Hume.

## DIFFICULTY OF IDENTIFICATION

Sunbury sees itself as the gateway to the Macedon Ranges.

The logo of the old "Shire of Bulla" City Living, Country Style" has considerable relevance for Sunbury.

It is separate from Melbourne and in particular the City of Hume both geographically and in many respects "culturally".

In real terms the "culture" of the town and the people who live within it's environs is totally different to those in the Melbourne Metropolitan area, and in particular Broadmeadows, Airport West and Tullamarine.

We value our "green" surroundings and have worked hard to retain them rather than the "Build at any cost" approach demonstrated by many of the Metropolitan Councilors for Hume.

### DIFFICULTIES WITH TRANSPORT

At the moment for a resident to visit the Council Offices located in Broadmeadows they need to have access to a car or motor bike.

Public Transport going directly to Broadmeadows is basically non-existent.

You must travel to Essendon by bus then train to Broadmeadows or by train to North Melbourne and another train to Broadmeadows – neither is very satisfactory at all.

## DIFFICULTY WITH SERVICES

More and more council services are being withdrawn out of Sunbury.

Council closed the local pound, which means for a local Sunbury Resident to retrieve an animal unfortunate enough to have been caught by the Ranger; they (the owner) must go all of the way to Whittlesea to collect their Pet..... .....if it hasn't been put down.

And now we find the situation with the basic council services such as the road maintenance teams needs to pick up their equipment from the Maffra Street Depot in Broadmeadows, drive all the way to Sunbury complete their work and drive all of the way back.

Without a doubt this will reduce their effective working time on the job in Sunbury leading to less work at a higher cost.

## CITY LIVING - COUNTRY STYLE

We have already spoken of the Shire of Bulla logo "City Living - Country Style"

There is no doubt that this "point of difference" to living in the suburbs has drawn many people to Sunbury.

One of our primary reasons for wanting to protect our "point of difference" is the fact that a number of the City Of Hume Metropolitan Councilors have shown by the decisions they have made in council, that they have no concern for the people of Sunbury and demonstrate that they have no empathy or basic understanding of the character and lifestyle we are working to develop and protect ...and they have made no effort to find out exactly what we want.

Basically, we are extremely concerned that the character and semi rural lifestyle will be destroyed if Sunbury remains part of Hume.

Evidence for this is found in a number of recent planning decisions which ran contrary to Hume's own planning guide lines and were overturned only after residents took the issues to the Administrative Appeal Commission.

## LACK OF BUSINESS OPPORTUNITY

When Sunbury was under the old Shire of Bulla many of the local businesses enjoyed the opportunity of being a supplier of goods and/or services to the Shire.

Not any more – a significant amount, if all, of the business has been lost to Sunbury Traders.


Apart from the direct business that was lost from the Shire itself, there is also the Business lost to the employee of the council who purchased from the local business in Sunbury.

#### ATTACHMENT 7 - ISSUES AND COMMENTS RAISED BY SUBMITTERS TO THE PANEL

The following summary aims to provide a flavour of the issues and comments made within submissions to the Local Government (*Hume City Council*) Review Panel.

This summary does not include extracts from the submissions of the Sunbury Residents Association or Australian Services Union, and their submissions are included in full as separate attachments.

Many of the comments made were similar in nature. This summary is not intended to be a complete analysis of all submissions, and does not include comments from every submission. However, the Panel believes it reflects the nature and strength of comments made.
