The Growing Suburbs Fund is a contribution towards meeting critical local infrastructure needs for communities in Melbourne's diverse and fast-growing outer suburbs. It is positioned to quickly respond to the pressures being experienced by interface communities by bringing forward local infrastructure projects that will make a big difference in the day-to-day lives of outer suburban families.



The Mornington Peninsula Shire is situated on a promontory located more than 40 km to the south east of Melbourne, with more than 190 km of coastal boundaries. It is characterised by a mix of urban areas, resort towns, tourist developments and rural land. The Peninsula is one of the major holiday and retirement destinations for Melbournians. The northern areas of the Shire have experienced significant residential development with improved road access in recent years. In 2017, the Shire had an annual population growth rate of 1.4 per cent and its population is forecasted to grow from about 163,200 in 2017 to 182,000, representing an 11 per increase by 2031¹.

Project Description: The Growing Suburbs Fund will partner with Mornington Peninsula Shire Council to deliver the Hastings Seniors Learning Hub project. This project is the upgrade and expansion of an existing facility that will provide a multi-use space accommodating adult education, learning programs, recreation and social activities, and general communityuse spaces.

The Hastings Seniors Learning Hub will include;

- New floor finishes throughout (except existing store room)
- Existing kitchen refurbishment and upgrade
- · New all abilities accessible amenities
- Existing male and female amenities to be refurbished and upgraded
- Installation of outdoor charging stations for scooters
- Building extension to house new open plan office, waiting area and reception with desk spaces, new allaccess entry, new computer room, new first aid room and new external storage
- External façade improvements
- Cosmetic work to the existing hall, ceiling, lighting and blinds.
