The Growing Suburbs Fund is a contribution towards meeting critical local infrastructure needs for communities in Melbourne's diverse and fast-growing outer suburbs. It is positioned to quickly respond to the pressures being experienced by interface communities by bringing forward local infrastructure projects that will make a big difference in the day-to-day lives of outer suburban families.



The Mornington Peninsula Shire is situated on a promontory located more than 40 km to the south east of Melbourne, with more than 190 km of coastal boundaries. It is characterised by a mix of urban areas, resort towns, tourist developments and rural land.

The Peninsula is one of the major holiday and retirement destinations for Melbournians. The northern areas of the Shire have experienced significant residential development with improved road access in recent years. In 2017, the Shire had an annual population growth rate of 1.4 per cent and its population is forecasted to grow from about 163,200 in 2017 to 182,000, representing an 11 per increase by 2031¹.

SPORTS GROWTH LIGHTING PACKAGE

Project Description: The Growing Suburbs Fund will partner with Mornington Peninsula Shire Council to deliver the Sports Growth Lighting Package Project which will see works undertaken to upgrade and install new critical lighting infrastructure at ten sporting reserves.

The Sports Growth Lighting Package seeks to address infrastructure gaps at senior, junior and sports facilities. The project will provide an upgrade of existing infrastructure to 100 lux standard at 6 sporting grounds, as well as the installation of new 50 lux floodlighting infrastructure at four junior and training facilities.

The Sports Growth Lighting Package will achieve benefits such as greater field carrying capacity, improved access to grounds and complying with playing standards.

The Sports Lighting Package includes the installation and upgrade including;

• Upgrade to existing infrastructure to 100 Lux Floodlighting at Alexandra Park, Mornington; Olympic Park Senior Oval, Rosebud; David McFarlan Reserve, Sorrento; RJ Rowley Reserve, Rye; Hastings Senior Oval, Hastings; and Barber Reserve, Somerville.
