

## BULLETIN: 105/2021

### COVID-19 UPDATE: 80 PER CENT STATE-WIDE SETTINGS

Victoria's Chief Health Officer has determined that on Friday 29 October at 6:00pm, Victoria will move forward in opening up and more restrictions will fall away. Metropolitan Melbourne and regional Victoria will be subject to the same state-wide settings under Phase C of the [Roadmap: Delivering the National Plan](#).

The new settings include eased density and capacity limits, if workers and customers are fully vaccinated.

**If workers and customers are not fully vaccinated with two doses, or venues do not check vaccination status, premises may be forced to close, or operate with reduced capacity limits.**

#### Phase C state-wide settings – both metropolitan Melbourne and regional Victoria

Premises	Fully vaccinated – staff and patrons	Vaccination status unknown
Hospitality	<ul style="list-style-type: none"> <li>• Small venues: up to 25 people</li> <li>• Large venues: indoors DQ4 (1 person per 4 square metres) applies with seated service.</li> <li>• Outdoors: DQ2 with a cap of 500 patrons and seated service is not required. Dance floors are permitted outdoors</li> <li>• Food courts: DQ4</li> </ul> <p>Masks can be removed to consume food and drink.</p>	<p>Closed, except for take away.</p> <p>All hospitality workers must be fully vaccinated by 26 November 2021 if they are working on site, even if they are only providing takeaway, as part of mandatory vaccination requirements for select workers.</p>
Accommodation	<p>Bookings are subject to the private gathering limit and are permitted for:</p> <ul style="list-style-type: none"> <li>• the person making the booking, plus</li> <li>• the other members of their household, plus</li> <li>• the intimate partners of the person or any member of their household, plus</li> </ul>	<p>Only fully vaccinated guests can access spaces with vaccination requirements, such as swimming pools and restaurants.</p>

	<ul style="list-style-type: none"> <li>10 additional people (dependants included, infants under the age of 1 excluded).</li> </ul> <p>Vaccination is strongly recommended for all guests. Density quotient of one person per four square metres applies to communal spaces indoors, and one person per two square metres outdoors.</p>	
Community facilities	Indoors: DQ4 Outdoors: DQ2 with a 500 person cap	Closed, except for essential public support services, which can run with a maximum of 10 people per space.
Creative arts studios	Indoors: DQ4 Outdoors: DQ2 with a 500 person cap	Closed
Entertainment and function premises	<ul style="list-style-type: none"> <li>Non-seated indoor venue: Fully vaccinated indoor DQ4.</li> <li>Seated indoor venue: Fully vaccinated 75 per cent capacity or DQ4 up to 1000</li> <li>Outdoor seated: Fully vaccinated DQ2 up to 5000 per venue. Indoor spaces DQ4</li> <li>Outdoor non-seated: Fully vaccinated DQ2 up to 5000, indoor spaces DQ4.</li> </ul>	Closed
Funeral parlours and crematoriums	Indoors: DQ4 Outdoors: DQ2 up to 500	DQ4 applies, maximum of 30 people.
Gaming machine premises	Indoors: DQ4 Outdoors: DQ2 with a cap of 500	Closed
Physical recreation premises	Indoors: DQ4 Outdoors: DQ2 outdoors up to 500	Community sport participants (players, coaches, officials and volunteers) can access facilities without showing vaccination status. Community sport spectators may access facilities without showing vaccination status, subject to public gathering limits of 30 people
Real estate	Indoors: DQ4 Outdoors: DQ2 up to 500 people	Inspection by private appointment with a single household, if vaccination status unknown.

Hair, beauty and personal care	Indoors: DQ4	Closed
Tours and transport	Indoors: DQ4 Outdoors: DQ2 with a 500 person cap	Closed

Businesses must verify their customers' vaccination status. If the customer has uploaded their COVID-19 Digital Certificate to their Service Victoria app, you will be able to see their vaccination status together with their check-in details.
